IMPLEMENTATION OF SCHOOL-BASED FEEDING PROGRAM-MILK FEEDING PROGRAM COMPONENT FOR SY 2024-2025

To: Public Schools District Supervisors
Public Elementary School Heads
All Others Concerned

- 1. With reference to DepEd Memoranda OM-OUOPS-2024-09-04944, OM-OUOPS-2024-09-04944, and OM-OUOPS-2024-09-04080, and DepEd Orders No. 31, s. 2021, No. 10, s. 2022 and No. 38, s. 2022, the School Governance and Operations Division School Health Section (SGOD-SHS) will implement the Milk Feeding Program Component of the School-Based Feeding Program for SY 2024-2025 starting February 18, 2025.
- 2. All public elementary schools are advised to take note of the following:
 - a. Pasteurized/fresh milk packs will be provided for nearby schools while sterilized and commercial powdered milk for far-flung schools. These should be distributed to the identified Severely Wasted and Wasted Grades 1 to 6 students in each school for 43 feeding days.
 - b. Pasteurized milk will be packed for each school based on the reported number of beneficiaries and delivered to the designated drop-off point (DOP) in each district twice a week. The sterilized and commercial powdered milk will also be packed according to the number of beneficiaries at each school, but it will be delivered only once to the DOPs.
 - c. The School Property Custodians shall claim the milk packs from their designated DOPs. The School Nurses and District Consolidators shall oversee the distribution of milk packs at the DOPs, including the overall implementation of the program.
 - d. The delivery schedule per municipality will be announced by the school nurses through the SBFP Group Chats per district.
 - e. The following schemes for milk pack distribution shall be observed in case of missed feeding days:
 - Double feeding may be conducted;
 - When calculating feeding days, class suspensions, holidays, and weekends can be included.
