- 2. The identified participants are advised to:
 - a. bring personal sleeping gear, sports supplies, and equipment;
 - b. wear division uniform during the opening program;
 - c. wear appropriate attire during the conduct of the training; and
 - d. present medical certificate taken from any government physician (not earlier than 15 days prior to the scheduled training) that he/she is physically fit to undergo intensive training.
- 3. Please be in the venue by 2:00 p.m. on Day 1 for registration and room assignment of participants. The first meal to be served will be dinner on February 20 while the last meal will be lunch on February 23, 2025.
- 4. A registration fee of One Thousand Eight Hundred Pesos (P1,850.00) shall be charged per participant to cover expenses on meals and snacks, training kits, certificates, bills and rentals, supplies, and other operational expenses incurred during the training. This shall be collected by the SOCCSKARGEN Physical Education and Schools Sports Association (SOCCPESSA) Treasurer.
- 5. To avoid disruption of classes, all concerned school heads are directed to assign relieving teachers to handle the classes left by the participating teachers. Appropriate service credits and compensatory time off, whichever is applicable, shall be granted to all personnel involved in the regional enhancement training.
- 6. The registration, travel, and other incidental expenses of participants shall be charged against local funds, subject to the usual accounting and auditing rules and regulations.
