ADMINISTRATION OF NATIONAL ACHIEVEMENT TEST TO GRADE 6 LEARNERS FOR SCHOOL YEAR 2024-2025

- 1. In reference to DepEd Memorandum No. 024, s. 2025 dated March 12, 2025, titled **Administration Of The National Achievement Test For Grade 6 (NATG6) For School Year 2024-2025**, the Curriculum Implementation Division reiterates the administration of the said exit assessment on April 2, 2025. This will be administered on a paper-based modality to all current Grade 6 learners of School Year 2024-2025 in public and private elementary schools.
- 2. The NATG6 is an exit assessment that is designed to determine if Grade 6 learners are meeting the learning standards in the elementary curriculum. The test design measures five learning areas (English, Mathematics, Science, Filipino, and Araling Panlipunan) in a multiple-choice format.
- 3. The Language of Testing for each learning area is as follows:

Language of Testing	Learning Areas
English	English, Science, and Mathematics
Filipino	Filipino and Araling Panlipunan

4. Relative to this, there will be an online orientation of all Chief Examiners (School Heads) of public and private elementary schools together with their respective school testing coordinators as well as the Project Development Officers per Municipality on March 21, 2025 (Friday) at 8:00 a.m. via Microsoft Teams:

- 7. Traveling, hauling, and other expenses relative to the conduct of this activity, including the distribution and submission of NATG12 test materials, shall be charged against local school funds. subject to the usual accounting and auditing rules and regulations.
