PHYSICAL EXAMINATION OF FIELD-BASED TEACHING AND NON-TEACHING PERSONNEL FOR CALENDAR YEAR 2025

To: Public Schools District Supervisors

Public Elementary and Secondary School Heads

- 1. In compliance with DepEd Memorandum No. 22, s. 2015 dated 19 March 2015, titled **Annual Physical Examination of DepEd Employees (Teaching and Non-Teaching Personnel)**, all field-based personnel in this Division are directed to undergo physical examination for the Calendar Year 2025.
- 2. This is to ensure that all employees are physically fit to perform their assigned tasks and functions, limit the risk of complications by monitoring existing health-related conditions, and provide baseline medical status to evaluate any occupational illness that might arise during employment.
- 3. The following diagnostic tests are required:
 - a. Complete Blood Count (CBC)
 - b. Chest X-ray (Sputum microscopy shall be required for pregnant women)
 - c. Urinalysis
 - d. Fasting Blood Sugar (FBS)
 - e. Cholesterol
 - f. Creatinine
 - g. Uric Acid
 - h. SGPT Blood Test
 - i. Abdominal Ultrasound (optional)
- 4. The validity of diagnostic tests is as follows:
 - a. CBC, Chest X-ray, Urinalysis Not more than 1 month
 - b. FBS, Cholesterol, Creatinine, Uric Acid, SGPT Not more than 3 months
- 5. The laboratory results must be attached to the Revised CS Form 86 to be signed by any government physician for medical clearance. The deadline for submission is May 31, 2025.
- 6. Failure to comply with this Memorandum shall be subject to disciplinary action pursuant to DepEd Order No. 49, s. 2006 (**Revised Rules of Procedure of the Department of Education in Administrative Cases**).
