SUBMISSION OF ENDORSEMENT AND UNDERTAKING FOR THE E-LEARNING COURSES SCHOLARSHIP PROGRAM FOR DEPED EDUCATORS - INTAKE 2

To: Assistant Schools Division Superintendent Functional Division Chiefs All Others Concerned

- 1. Relative to the commencement of the NEAP's E-Learning Courses Scholarship Program Intake 2, this Division is on the process of selecting the participants for the said batch. Previously identified participants by NEAP in Intake 2 and Intake 3 shall be given priority. In case the identified participant is already separated in service or opt to submit a waiver or has been included in the Intake 1, the school head is authorized to select for their replacement.
- 2. The selection of participants must strictly adhere to the following qualifications and parameters to ensure transparency, fairness, and alignment with program:
 - a. FY 2024 Performance Individual Performance Commitment and Review Form (IPCRF) Rating: Priority shall be given to educators with at least two (2) years of service based on their FY 2024 IPCRF ratings, with consideration to the following categories:
 - Teachers I-III needing intervention
 - Master Teachers I-III needing intervention
 - High-Performing Teachers I-III
 - Head Teachers aiming for reclassification to teaching career line
 - b. Digital Readiness: Participants must possess digital literacy and must be equipped with the necessary resources such as computer/laptop and stable internet connection to access and navigate the LinkedIn Learning platform.
- 3. Relative to this, the concerned School Heads are directed to submit an endorsement of the participants along with the copy of Undertaking (Long size in 3 copies) on or before May 21, 2025, at the Human Resource Development Section (HRDS).
