- 1. Article XIV, Section 19, Paragraph 2 of the Philippine Constitution states that "All educational institutions shall undertake regular sports activities throughout the country in cooperation with athletic clubs and other sectors".
- 2. In pursuance to the Memorandum Order No. 9 s. 2005 otherwise known as Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance therewith, and in compliance to DepEd Order No. 12 s. 2025 titled School Calendar and Activities for the School Year 2025-2026, All Public Schools of the Division Office of Sarangani shall conduct the following:
 - a. School Intramurals August 2025
