ORIENTATION AND TRAINING ON READING INTERVENTION AND ARAL PROGRAM FOR VOLUNTEER AND TEACHER TUTORS – MUNICIPALITY OF KIAMBA

To: Assistant Schools Division Superintendent Chief Education Program Supervisors Public Schools District Supervisors Schoolheads

- 1. In support of **DepEd Order No. 018, s. 2025**, titled "Implementing Guidelines of the Academic Recovery and Accessible Learning (ARAL) Program," a **3-day orientation and training** will be conducted for **volunteer tutors and ARAL Program Teacher Tutors** in the Municipality of Kiamba on **August 4–6, 2025** at **Kiamba Central School SPED Center Gymnasium**. This initiative is part of the Department's mandate to engage volunteer tutors and teacher-tutors as **school-community partners** in delivering targeted and responsive academic recovery interventions.
- 2. This orientation-training aims to:
 - a. Equip participants with a foundational understanding of the **ARAL** program's goals, methodologies, and expected outcomes.
 - b. Develop participants' **core tutoring skills**, effective communication, and **adaptive teaching strategies** for diverse learners.
 - c. Foster a **collaborative spirit** among volunteer tutors and teacher tutors, establishing clear communication channels and **support mechanisms** for ongoing program implementation.
- 3. The participants of this activity are the **34 tutor volunteers** to be deployed to the various schools in the Municipality of Kiamba and **one (1) regular teacher** from each school. Meanwhile, attached is the letter of approved request on the attendance of selected speakers/facilitators for the said activity.
- 4. Participants are expected to bring their own materials, which can be accessed https://bit.ly/DREAMUP-ACADEMY.
- 5. In compliance with existing DepEd policies on the **protection of instructional time and prevention of class disruptions**, school heads must ensure that **no regular classes are interrupted**. When necessary, **distance learning modalities** such as asynchronous or modular delivery may be utilized to allow teacher participants to attend without affecting classroom instruction.
