Furthermore, they must implement appropriate Catch-Up Program interventions for classes missed by the participants through alternative learning modalities, such as the distribution of Self-Learning Modules (SLMs) or Learning Activity Sheets (LASs), in accordance with existing DepEd guidelines:
- DepEd Order No. 12, s. 2025 – School Calendar and Activities for the School Year 2025–2026, which highlights the implementation of catch-up interventions and the use of alternative delivery modes.
  - DepEd Order No. 12, s. 2020 – Adoption of the Basic Education Learning Continuity Plan (BE-LCP), which includes provisions for Self-Learning Modules and Learning Activity Sheets to ensure learning continuity during absences.
  - DepEd Order No. 66, s. 2017 – Implementing Guidelines on the Conduct of Off-Campus Activities, which requires informed consent from parents or guardians.
5. Travel and other incidental expenses incurred shall be charged against their respective school MOOE funds or any applicable local funds subject to the usual accounting and auditing rules and regulations.
