SUBMISSION OF JUSTIFICATION LETTER ON THE NON-COMPLIANCE OF FIELD-BASED EMPLOYEES' ANNUAL MEDICAL AND PHYSICAL EXAMINATION 2025

To: Public Schools District Supervisors
Public Elementary and Secondary School Heads
All Concerned

- 1. In reference to Division Memorandum No. 051, s. 2025, all field teaching and non-teaching employees are required to undergo an **Annual Physical and Medical Examination**. Field-based teaching and non-teaching employees, who are non-compliant and have incomplete diagnostic tests, including employees on official leave, such as maternity leave, are required to submit a justification letter.
- 2. The justification letter shall be addressed to the **Schools Division Superintendent** and must clearly state the reason for non-compliance or incomplete medical examination and the specific date when the employee intends to comply the required examination. Failure to submit the justification letter shall be dealt accordingly through administrative action.
- 3. In addition, **school heads** are likewise required to submit a separate justification letter explaining the reasons for their personnel's non-compliance or failure to complete the required medical examination. Both letters must be personally submitted to the assigned district nurse on or before **July 25, 2025**.
- 4. Attached herewith are the lists of employees who have not complied with the Annual Physical Examinations and those with incomplete diagnostic tests.
