CONDUCT OF DIVISION BASELINE DATA COLLECTION TO NON-FUNCTIONAL SCHOOL GOVERNANCE COUNCILS (SGCs) USING THE TECHNICAL ASSISTANCE EFFECTIVENESS SURVEY TOOL

To: Assistant Schools Division Superintendent Chief Education Supervisors Public Schools District Supervisors Public Elementary & Secondary School Heads All Others Concerned

- 1. In reference to Regional Memorandum FTAD-2025-007 titled "Conduct of Regional Baseline Data Collection to Non-Functional School Governance Councils (SGCs) Using the Technical Assistance Effectiveness Survey Tool", this Division shall conduct a baseline data collection on the effectiveness of technical assistance (TA) provided by the Division Composite Team (DFTAT) to non-functional School Governance Councils (SGCs).
- 2. The primary objective of this activity is to gather substantial inputs and feedback from School Heads, Teachers, and Stakeholders prior to the provision of technical assistance in line with DepEd Order No. 26, s. 2022, otherwise known as the Implementing Guidelines on the Establishment of School Governance Councils.
- 3. The baseline data collection period is scheduled from July 28 to August 15, 2025. School Governance Council (SGC) focal persons are directed to disseminate the Technical Assistance Effectiveness Survey Tool (TAEST) using the official Google Form link: https://bit.ly/4kmwNLI.
- 4. RO-FTAD will consolidate responses from August 18 to 29, 2025. It is expected that all school-based responses are submitted before the end of the data collection period.
- 5. Activities that will be conducted during weekends and holidays shall follow the provision of Compensatory Time-Off (CTO) in accordance with DepEd Order No. 53, s. 2003 and CSC-DBM Joint Circular No. 2, s. 2015.
- 6. All related expenses incurred shall be charged against local funds, subject to existing budgeting, accounting, and auditing rules and regulations.
