**IMPLEMENTATION REVIEW OF READING ACTIVITIES CUM PLANNING  
CONFERENCE IN JOURNALISM**

To: Schools Division Superintendents  
Education Program Supervisors in English and Filipino

1. To ensure the effective implementation of programs, projects, and activities in Reading and Journalism, DepEd SOCCSKSARGEN, through Curriculum Learning Management Division, shall conduct **an Implementation Review of Reading Activities Cum Planning Conference in Journalism on September 18-20, 2025**. The venue of the activity will be announced thru a separate announcement.
2. The activity shall be conducted purposely to:
  - a. re-orient the supervisors with Phil-IRI and CRLA administration, and gathering of data;
  - b. analyze the 2025 Phil-IRI and CRLA results;
  - c. report on the Phil-IRI fund utilization;
  - d. monitor progress and assess the implementation of ARAL-Reading;
  - e. discuss relevant program implementation issues;
  - f. plan and discuss logistics for the Regional Schools Press Conference; and
  - g. provide technical support to the Division Education Program Supervisors in preparing their respective program plans for the implementation of DSPC.
3. Participants in this activity from the Regional Office are the CLMD Chief and Education Program Supervisors. Meanwhile, the participants from SDOs include Education Program Supervisors in English and Filipino, as well as Division Reading Coordinators.
4. All Division Reading and Journalism Supervisors are enjoined to prepare a 5-minute presentation covering the following:
  - a) Assessment Results of Phil-IRI and CRLA
  - b) Least-learned competencies in Reading (Grade 1)
  - c) Phil-IRI fund utilization (printing)
  - d) Journalism activities for 2025-2026
  - e) Winners in NSPC through a graphical presentation 2023-2025
5. The Division Reading and Journalism Supervisors shall access the template for the presentation through <https://tinyurl.com/Report2025>. The presentation of each division shall be submitted on the same link **on or before September 11, 2025**.
6. The board and lodging of the participants shall be charged against the **OSEC-12-24-7700** Program Support Fund, while the travel expenses shall be charged against their local funds, subject to the usual accounting and auditing rules.
