# GENERAL GUIDELINES OF ACTIVITIES FOR DEPED SARANGANI CELEBRATION OF THE 125<sup>TH</sup> CIVIL SERVICE ANNIVERSARY

- 1. All activities are open to all non-teaching personnel of this Division except those that are identified as Technical Working Group shall be barred from joining any of the games.
- 2. Game referee's/judge's decision shall be final and irrevocable.
- 3. There shall be 4 teams for the larong pinoy and 4 teams in the ballgames;
- 4. The teams shall be in clustering: **Team 1 (Division-Alabel), Team 2 (Glan-Malapatan), Team 3 (Malungon) and Team 4 (MAKIMA)**;
- 5. The team shall identify one person as contact person and responsible for coordinating communications and facilitating engagements of the team;
- 6. The team shall be composed of 1 Coach and 12-player in Basketball (men) and Volleyball (women);

## DepEd Celebration of the 125th Civil Service Anniversary

### **BASKETBALL (MEN):**

#### I. RULES AND REGULATIONS

(The International Basketball Federation (FIBA) – Valid as of October  $1^{\rm st}$  2023 shall govern the CSC Sports Meet 2024 Basketball competition

## I.1 TIMING REGULATIONS

The official FIBA 2023 Rules shall apply with the latest amendments.

- 1. Beginning and End of the Quarter, Overtime or the Game.
- 2. Player's Injury
- 3. Player's in an act of shooting
- 4. Illegal Cylinder
- 5. Goal Tending/Basket Interference
- 6. Double Foul
- 7. Unsportsmanlike Foul
- 8. Throw-in Foul
- 9. Interval of Play
- a. Sec. Shot clock
- 10. The Interval between the quarters, is one (1) minute while interval between halves, is (5) minutes.

### II. PLAYERS PLAYING REGULATIONS

- 1. All players of the team shall be fielded before the end of the second quarter or within the first half FAILURE of the coach to field a player in the 1<sup>st</sup> half shall be penalized with the Technical Foul (1FT only) charged to the coach.
- 2. All players shall play at least one (1) quarter but not more than three (3) quarters and shall be rested by one (1) quarter. If a coach fielded a player for more than three (3) quarters, shall be penalized with a Technical foul charged to the coach.
- 3. Normal substitutions procedures shall apply in all quarters. (Except when a certain rule does not apply). A player may enter in a game as a substitute as many times as possible within that quarter and considered as having played only in that quarter.
- 4. One (1) time out for every quarter shall be granted to each team for the first three (3) quarters and two (2) timeouts shall either be used or forfeited.
- 5. In case a team has an incomplete line up during the schedule game.
  - 5.1The 1st quarter shall always start with 5 players while the other quarters may be played with remaining members of the team.

#### INTERPRETATIONS OF RULE VII.

#### **EXEMPTIONS:**

a.) IN CASE OF INJURY/DISQUALIFICATIONS:

(In the 1<sup>st</sup>/ 2<sup>nd</sup> quarter) – an injured player may be substituted by any player, and as such said" substitute player and injured player "shall be considered as having played in any particular quarter.

The "injured player" upon recovery may re-enter in the same quarter or may play in any quarter following Sec.1. Rule VII.

IMPORTANT Reminder: WHENEVER POSSIBLE AND IF THE RULES WILL ALLOW, EVERY QUARTER SHALL BE PLAYED ALWAYS WITH FIVE (5) PLAYERS.

#### III. COMPOSITION OF THE CONTINGENT/DELEGATION

## A. Team Composition

A team shall be composed of not more than 12 team members with 1 Head Coach (12+1).

# B. Eligibility

Players should be a bonafide employee, regardless of its status of appointment (permanent, casual, coterminous or job order), of the agency he is representing.

#### C. Coach

A team shall have a responsible Coach and attend the "Preliminary Inquiry" and bring with them a copy of certification from the head of agency as to players' the legitimacy of employment to their respective agencies. Copies of the employee's ID shall also be attached.

Only the Coach shall be allowed to stay within the team bench during official games

#### IV. DISQUALIFICATION

- 1. A Thrown- out player must leave the confines of the playing area.
- 2. A player / coach who is disqualified as a result of a disqualifying foul/ fighting, Intentional foul, two (2) Unsportsmanlike fouls shall be automatically suspended. The number of games of suspension shall be determined by the Technical Committee and will be based on the gravity of the act (Except players with two technical fouls).

#### A. FOULS

1. TECHNICAL FOULS- any PLAYER/COACH who displays unsportsmanlike/ disrespectful act such as slashing of neck, showing of dirty fingers, pointing of accusing fingers and trash talking / shouting bad words/ foul language, contesting calls, arguing with the officials and the others. A WARNING maybe given or a TECHNICAL FOUL shall be slapped.

- 2. PERSONNAL FOULS- players causing contact with the opposing, playmate, which gives an unfair advantage and such contact are neither intentional nor flagrant.
- 3. FLAGRANT FOULS- a player causing contact excessive contact which may cause or have caused injury to an opponent, such as; a. excessive of elbow, b.) Throwing a punch, c.) Tripping, d.) Intentional contacting/ pushing the back of the player going for a basket shall be judged to be either an Unsportsmanlike/Disqualifying Fouls.

## B. Players / coaches' conduct:

- 1. Any player /coach, who is slapped with a Disqualifying Foul and ejected because of Flagrant Unsportsmanlike Action/ Conduct, shall be penalized accordingly **PLUS an additional 1 game suspension** /total disqualification or banned from further participation, depending on the gravity of the offense. (Except players who committed Technical Fouls).
- 2. Uttering / shouting of obscene/foul language /bad words or verbal abuse from players /coaches to opponents/officials or teammates shall not be tolerated such as act shall be dealt with a warning or a Technical Foul. The COACH shall be responsible for the DISCIPLINE and BEHAVIOUR of the followers, supporters and friends of the team.
- 3. Coaches shall always confirm their next schedule of the game with the Tournament Manager BEFORE leaving the playing venue / or after their game.
- 4. A team that walks out of their game shall be penalized with a Disqualification from the competition and likewise the coach shall be *BANNED*.

# V. CONDUCT OF THE COMPETITIONS

V.1 Competition format: Single Round Robin

### VI. DETERMINATION OF WINNER

The winner of the Final Round will be declared CHAMPION.

# **REGULAR VOLLEYBALL (WOMEN):**

#### A. Tournament Rules and Guidelines:

## 1. Participants/players

- 1.1. Team composition. Including the Liberos, each team shall have a maximum of 12 players plus 1 coach.
- 1.2. The LIBERO: The coach has the option to field in any of the LIBEROS. The replacement of Libero shall be unlimited amongst them. No way that the two liberos shall be fielded at the same time in the same set.
- 1.3 **ELIGIBILITY**: Players should be a bonafide employee, regardless of its status of appointment (permanent, casual, coterminous or job order), of the agency he is representing.

- 2.1 This tournament shall be governed by the rules and regulations of FIVB subject to changes as determined by the committee.
- 2.2 The tournament will follow a single round-robin format.
- 2.3 All elimination round matches will be played to 30 points. A court switch will occur when either team reaches 15 points. A two-point advantage is required to win any set and/or a match.
- 2.4 During the semi-final rounds, crossover matches shall be conducted-rank 1 vs rank 4, and rank 2 vs rank 3. Matches will be played to 30 points. A court switch will occur when either team reaches 15 points.
- 2.5 The Championship Match shall be played in a best-of-three sets format. The first two sets shall be played to 25 points, while the third set, if necessary, shall be played to 15 points. In the third set, teams shall switch sides of the court when either team reaches 8 points. A two-point advantage is required to win any set.
- 2.6 Ranking System. In case of tie (2 teams have the same standing), win over the other will be applied. In the event of triple tie (3 teams have the same standing), the following shall be implemented.
  - 2.6.1 Number of victories the teams shall be classified in descending order by the number of matches won.
  - 2.6.2 Ranking Points In the case of equality in number of matches won the ranking points will be considered. Wherein winner is equivalent to 2 points, loser is equivalent to 1 and game forfeited is equivalent to 0.
  - 2.6.3 Set Ratio Nevertheless, after the ranking points and still the 3 or more teams have the same standing, set ratio will be applied. It will be done by getting the quotient of the number of all sets won by the number of all sets lost.
  - 2.6.4 Points Ratio If the tie persists as per the set ratio, the teams will be classified in descending order by the result of dividing all points scored by the total points lost during all sets.

Note: If the tie continues as per set ratio, a new classification of these teams in terms of points 1, 2, 3 will be made taking into consideration all the matches they played. Ranking of teams will be based always on FIVB rules. For triple tie, ranking points will be applied as indicated below:

4.1. Height of the net:

Women - 2.24 meters

### 5. Other important Points

### 5.1. General Rules:

- 5.1.1. This volleyball competitions shall be held in accordance with the latest rules of International Volleyball Federation (FIVB) and as modified by/supplemented by the guidelines stated hereunder;
- 5.1.2. In case of any dispute on the text, the English version of the latest FIVB Rules shall prevail.
- 5.1.3. Any unforeseen event not covered by the rules shall be dealt with as follows:
- 5.1.3.1. Technical questions shall be resolved in accordance with the Technical Guidelines, rules, and regulations of volleyball.
- 5.1.3.2. Questions on eligibility shall be resolved in accordance with the screening and eligibility guidelines.
- 5.1.4. The law of succession shall be applied.
- 5.1.5. Smoking is strictly prohibited in the playing venue. Anybody under the influence of liquor is not allowed as well.
- 5.1.6. All teams and players are required to maintain, display, or practice the virtue of sportsmanship before, during and after the game regardless of loss, win or protest. As a gesture of magnanimity, the players and coaches of both teams shall meet at the center of the court and shake hands before and after the game.
- 5.1.7. The decision of the referee is final and irrevocable.

### 5.2 Participants' Conduct

- 5.4.1 Participants must know the "official volleyball rules" and abide by them.
- 5.4.2 Participants must accept the Referee's decision with sportsmanlike conduct, without disputing them.
- 5.4.3 Participants must refrain from actions or attitude aimed at influencing the decision of the referees or covering up the faults committed by their team. Otherwise, verbal warning shall be issued to Player/team/coach.
- 5.4.4 Participants must behave respectfully and courteously in the spirit of fair play not only toward the referees but also towards the officials, the opponents, teammates, and spectators (FIVB Rule 20.2.1).

### 5.3 Conduct during the Competition and Corresponding Penalties

5.3.1 Sanctions. All forms of misconduct during competition shall be subject to sanction in accordance with the sanction scale (FIVB Rule 21.3)

5.3.2 Default. A team that does not appear fifteen (15) minutes after the scheduled time of their game shall be declared in default in favor of the opposing team.

## 5.4 Prolong Interruptions.

- 6.7.1 Interrupted matches, even if it exceeds four hours. and played in another venue (i.e., due to unfavorable instances like rain and other disturbances) match shall continue with the same scores, players, and position. Interrupted set shall continue normally, with the scores of completed set/s kept as played.
- 6.8. Waiver from the players should be provided and submitted to the officiating official

## 5.5 Protest/ Complaints

- 5.5.1. Protest on eligibility shall be addressed to the Screening/Eligibility Committee while protest on Technicality shall be addressed to the Technical Manager/Tournament Manager. Such protest must be submitted /presented in writing within thirty (30) minutes period after the game in question duly signed by the team captain and coach accompanied with the proof of evidence.
- 5.5.2 In case the protest is pursued, and the concerned player has been found to be ineligible, the team fielding ineligible player shall be penalized by forfeiting all games without prejudice to punitive sanction such as suspension or disqualification from coaching.

# LARONG PINOY:

#### Tug of War-

- 1. Two teams compete by pulling on opposite ends of a rope;
- 2. Each team shall be composed of 10-member;
- 3. A marker (usually a flag or tape) is placed at the center of the rope.
- 4. The objective is to pull the other team a certain distance (often marked on the ground) past a central point.

#### Sack Race-

- 1. Participants **stand inside sacks** (usually made of burlap or similar material);
- 2. Each Team shall be composed of 10-member;
- 3. Holding the sack up with their hands, they must **hop** forward to a finish line;
- 4. The first to cross the line without falling or leaving the sack wins.

## Jumping Rope-

- 1. Each team shall be composed of 5-member;
- 2. Two players hold the ends of the rope (turners) and one or more players take turns jumping inside the rope;

- 3. The jumper enters the rope without stopping its swing;
- 4. The goal is to jump over the rope continuously without tripping;
- 5. If the rope touches the jumper, their turn ends, and the next player goes in;
- 6. The player who jumps the longest without tripping wins;
- 7. The team tries to reach a target number of successful jumps together.
