5. Schools Division Office (SDO) personnel especially the Public Schools District Supervisors will lead in monitoring the activity in their district/municipality while other division personnel may choose their school where to attend/participate on this Celebration.
6. Expenses incurred by the schools relative to this activity are chargeable against school MOOE, while the division-led initiatives are chargeable against Division MOOE subject to the usual accounting and auditing rules and regulations.
