

Save the Children Philippines, in partnership with the Department of Education (DepEd) - Sarangani Division, is implementing the **Catch-up Clubs (CuCs)** program, an innovative learning recovery initiative designed to help struggling learners regain foundational literacy skills through fun, safe, and inclusive play-based sessions. The program continues to serve as a bridge for learners most affected by learning loss, ensuring that they are supported not only academically but also socially and emotionally through engaging and child-centered approaches.

To sustain quality implementation and to ensure that the CuC learning resources remain relevant and aligned with DepEd's learning standards, Save the Children has developed a set of contextualized tools and learning materials that now require formal validation by the DepEd Sarangani Division. These include:

- CuC Activity Modules in English and Filipino, and
- CuC Session Outline

The validation activity aims to gather expert feedback from DepEd curriculum supervisors, education program specialists, and selected teachers on the accuracy, appropriateness, and usability of these materials in supporting learners' foundational skills and holistic development. This collaborative process reflects the shared commitment of DepEd and Save the Children to ensuring that learning recovery initiatives are pedagogically sound, child-friendly, and adaptable to various school contexts.

Specifically, the activity will:

- Present the CuC learning materials for technical review and validation;
- Gather recommendations from DepEd supervisors and specialists to enhance the quality, accuracy, and contextual relevance of the materials;
- Ensure alignment of the CuC materials with DepEd's learning competencies and standards in literacy and life skills education; and
- Finalize validated versions of the CuC modules, guides, and story booklets for official use in CuC implementation within Sarangani and other expansion sites.

In relation to the above, the **Catch-up Clubs Activity Modules** focus on developing competencies that are closely aligned with the Department of Education's **Reading and Language Competencies for Kinder to Grades 3–5**, particularly in **Filipino and English**. It builds the following core areas:



1. Foundational Literacy Competencies

- **Letter to Word Levels:** Recognizing letters, phonemes, and syllables; expanding vocabulary; building words and sight words – aligned with Kinder to Grade 2 competencies on phonemic awareness and basic reading.
- **Sentence to Story Levels:** Constructing sentences, sequencing ideas, and improving comprehension – aligned with Grades 2–5 competencies on grammar, comprehension, and composition.
- **Advanced Reading Comprehension:** Cause and effect, main idea, comparison, and character analysis – aligned with Grades 4–6 competencies on higher-order reading skills.

2. Social and Emotional Learning (SEL) Competencies

- Promotes self-awareness, self-management, social awareness, relationship skills, and responsible decision-making, complementing DepEd's Edukasyon sa Pagpapakatao (EsP) framework and values formation standards.

These competencies support DepEd's learning domains in **Listening and Speaking**, **Reading and Viewing**, **Writing and Composition**, **Vocabulary Development**, **Grammar Awareness**, and **Values Education**. The CuC curriculum thus serves as a remedial and bridging literacy program that aligns with the national K–12 standards and reinforces the goals of inclusive and equitable quality education for all learners.

The Validation Workshop is scheduled on November 14, 2025 (Friday), from 8:00 a.m. to 4:00 p.m., at Microtel by Wyndham Boardroom, General Santos City.
