1. Aligned with this mandate, DepEd-SOCCSKSARGEN Region shall conduct the **"Regional Supreme Elementary Learner Government (SELG) Federation Officers Summit 2025 Cum Regional Children's Month Celebration"** on **November 13-14, 2025 at Mt. Sabrina Panoramic View Resort, Barangay Tambler, General Santos City.**

2. Celebrating with the theme, **"OSAEC- CSAEM Wakasan: Kaligtasan at Karapatan ng Bawat Batang Mag-aaral, Ipaglaban"**, this activity is a face-to-face engagement of Region and Division Federation Officers of SELG and Teacher-advisers from eight schools divisions all over the region.
