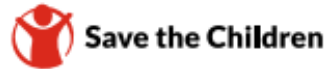

Greetings from Save the Children Philippines!

Save the Children Philippines, in collaboration with the Department of Education (DepEd) – Sarangani Division, continues to advance the Catch-up Clubs (CuCs) program. This initiative is designed to help learners who have experienced setbacks in literacy regain essential skills through engaging, inclusive, and play-based sessions. Beyond academics, the program also nurtures children's social and emotional growth, ensuring a holistic approach to learning recovery.

To further strengthen the program, Save the Children has prepared contextualized learning resources that now require formal validation by the Division Office. These include:

- CuC Activity Modules in English and Filipino
- CuC Session Outline

The upcoming workshop marks the **second stage of the validation process**. Following the initial review, validators recommended an extended session to examine additional materials and provide more detailed feedback. This step is crucial to refining the tools, so they remain accurate, context-sensitive, and practical for classroom use.

The activity will:

- Collect recommendations from DepEd supervisors and specialists to enhance quality and contextual relevance;
- Ensure alignment of the CuC materials with DepEd's literacy and life skills standards; and
- Finalize validated versions of the modules, guides, and story booklets for official use in Sarangani and future expansion sites.

The Catch-up Clubs Activity Modules are closely tied to DepEd's Reading and Language Competencies for Kinder to Grades 3–5 in both Filipino and English.

Together, these competencies reinforce DepEd's domains in listening, speaking, reading, writing, vocabulary, grammar, and values education. The CuC curriculum serves as a remedial and bridging literacy program aligned with K–12 standards and the broader goal of inclusive, equitable education.

The Validation Workshop is scheduled on **December 9 and 10, 2025 (Tuesday and Wednesday)**, from 8:00 a.m. to 4:00 p.m., at Microtel by Wyndham Boardroom, Valley High, Philippine National Highway, General Santos City.
