**EARLY REGISTRATION AND SCHOOL READINESS MONITORING AND
PROVISION OF TECHNICAL ASSISTANCE**

To: Schools Division Superintendents

1. Pursuant to **DepEd Order No. 012, s. 2025** titled Implementing Guidelines on the School Calendar and Activities for School Year 2025-2026, all Schools Division Offices are enjoined to actively participate in the **Early Registration** for incoming Kinder, Grades 1, 7, and 11 for SY 2026-2027 scheduled on **January 31 - February 27, 2026**.

2. The Regional Field Technical Assistance Teams (RFTATs) shall be deployed on **February 10-13, 2026**, while Division Field Technical Assistance Teams (DFTATs) shall provide support on the official dates of the Early Registration. All deployed teams, both RFTATs and DFTATs, are expected to observe and strictly comply with the Terms of Reference as follows:

- a. Gather data on the following:
 - Enrolment segregated by gender, age and ethnicity
 - Classrooms and furniture
 - Learning materials
 - ICT equipment
 - Teachers' Profile by gender, age, plantilla status
 - Special Programs Offerings
 - Number of teachers untrained in the Revised K to 10 Matatag Curriculum
- b. Monitor and provide evidence-based, appropriate and relevant technical assistance to ensure readiness of schools
- c. Identify issues and concerns requiring regional office action
- d. Document best practices related to the conduct of Early Registration
- e. Submit Technical Assistance Reports and filled-out monitoring tool to the head of office/unit. (For RO, the summary of TA Reports per functional division shall be submitted to FTAD.)

3. SDOs, through the Planning Office, shall ensure On-Time Reporting of enrolment data and related information as required by DO 012, s. 2025. Reports shall be submitted to the Regional Planning Office every Monday, starting **February 5, 2026**.
