RENAMING OF PULATANA INTEGRATED SCHOOL TO LINDA AGOS BUAN
INTEGRATED SCHOOL

To: Assistant Schools Division Superintendent
Public Schools District Supervisors concerned
Public and Private Elementary and Secondary School heads

1. With reference to the Resolution No. 2026-260-16 from the Office of the Sangguniang Bayan of the Municipality of Malungon, dated February 16, 2026, please be informed of the adoption of the proposed change in the name of Pulatana Integrated School to **Linda Agos Buan Integrated School**.
2. Public elementary and secondary schools may be named after their location or donor of the school, if (apart from donating the lot) the donor has also reached a level of public achievement and recognition. The naming of school after a living person is prohibited by Republic Act No. 1059, except where there is a special provision to name it so, as when so provided in the deed or donation.
3. Section 99 (d) of Republic Act 7160, otherwise known as the Local Government Code, provides that the Local Sangguniang has the power to change the name of the school through an ordinance and upon recommendation of the School Board. Approval of the Secretary of Education is no longer necessary.
4. Per evaluation / proper scrutiny of required documents, to wit:
 1. Request letter by heirs for the change of name,
 2. Joint PTA and Barangay Resolution favoring the change of name,
 3. Strong recommendation / resolution / ordinance by Sangguniang Bayan, duly indorsed by the School Board; and
 4. Original copy of Deed of Donation.
5. This Division finds that the correctness of required documents has properly met the standards for the change of name per R. A. 7160.
6. Application now is deemed approved, and the change of name will take effect immediately upon receipt thereof.


