ON THE ARAL PROGRAM IMPLEMENTATION

1. Relative to the implementation of the Academic Recovery and Accessible Learning (ARAL) Program under DepEd Order No. 018, s. 2025 and DepEd Memorandum No. 064, s. 2025, the Curriculum Implementation Division will conduct monitoring and evaluation, instructional supervision, and provision of technical assistance for the 1st Term of the SY 2026-2027 implementation of ARAL Program on July 20 to September 15, 2026.

2. This activity aims to:

- Monitor and evaluate ARAL Program implementation in schools;
- Conduct instructional supervision on lesson delivery and curriculum alignment;
- Provide technical assistance to strengthen and implement an effective program.

3. All schools are directed to establish an ARAL Corner in the office, reading centers/hubs, or classrooms. This must contain and compile the following means of verification (MOVs):

- List of ARAL learners with pre-assessment reading levels (CRLA, PHIL-IRI)
- List of ARAL classes with learners per teacher
- Individual profiles of struggling readers (non-decoders under ARAL Basic)
- List and profiles of ARAL teachers (DepEd and Non-DepEd)
- Class programs (including for Non-DepEd ARAL teachers)
- Contracts of Service/MOA for Non-DepEd ARAL Volunteers
- Parents' consent and commitment forms
- Stakeholders' commitments to ARAL
- ARAL Teachers' Guides (1:1)
- Learners' materials (1:1) and supplementary materials (if available)
- School ARAL Implementation Plan
- CRLA, PHIL-IRI, and MFAT results (consolidated and individual)

- n. Progress tracking/check-in results
- o. ARAL Teachers' Individual Reading Intervention Plans (IRIP)
