**CREATION OF THE VALIDATION SUB-COMMITTEE FOR THE RE-VALIDATION  
OF REPORTED DEPED PERSONNEL WITH HOUSEHOLD DAMAGES DUE TO  
TYPHOON INDAY (BAVI)**

To: Assistant Schools Division Superintendent

1. In view of the reported household damages sustained by teaching and non-teaching personnel brought about by **Typhoon Inday**, and to ensure the accuracy, fairness, and integrity of the damage assessment prior to the provision of assistance and inclusion in official reports, this Division Incident Management Team (DIMIT)- Emergency Operations Center (EOC) hereby creates the **Validation Sub-Committee** to conduct the re-validation of all reported household damages incurred by DepEd personnel.
2. The re-validation aims to:
  - a. Verify the actual condition and extent of damages sustained by the households of affected DepEd personnel;
  - b. Validate the classification of damages as **Totally Damaged** or **Partially/Minor Damaged** based on existing assessment guidelines;
  - c. Ensure that all reported information is supported by appropriate documentary evidence and field validation;
  - d. Establish an updated and reliable database of affected DepEd personnel to serve as basis for resource allocation, donor matching, and other recovery interventions.
3. The Validation Sub-Committee shall be composed of the following:

4. The Validation Sub-Committee shall conduct re-validation through any of the following appropriate means:

- On-site field validation and inspection;
- Telephone or mobile phone interviews;
- Online interviews through video conferencing platforms (e.g., Google Meet, Zoom, Messenger, Video Call, or similar applications);
- Coordination with the concerned School Head and Public Schools District Supervisor (PSDS); and
- Any other practical and reliable platform or mechanism deemed necessary by the Validation Sub-Committee to establish the accuracy of the reported household damage.

5. The re-validation shall commence immediately upon receipt of this Memorandum and shall be completed within five (5) days to facilitate the timely processing of assistance and preparation of official reports.

6. Travel and other incidental expenses incurred during the conduct of validation activities shall be charged against available local funds, subject to the usual accounting and auditing rules and regulations.
