**RE-ORIENTATION AND TECHNICAL WORKSHOP ON GOVERNMENT PERMIT (GP), GOVERNMENT RECOGNITION (GR), TRANSITIONING TO THE STRENGTHENED SENIOR HIGH SCHOOL (SSHS) CURRICULUM, AND PREPARATION OF SSHS CLASS PROGRAMS FOR PRIVATE EDUCATIONAL INSTITUTIONS.**

1. In line with the Department of Education's commitment to ensuring quality basic education delivery and regulatory compliance among private basic education institutions, and pursuant to DepEd Order (DO) No. 11, s. 2026 (*Revised Guidelines on E-GASTPE*), DO No. 12, s. 2026 (*Guidelines on the Recognition of Private Senior High Schools*), and DO No. 17, s. 2026 (*Policy Guidelines on the Implementation of the Strengthened Senior High School Curriculum*), the Schools Division Office (SDO) of Sarangani will conduct an online Re-Orientation and Technical Workshop on Government Permit, Government Recognition, Transitioning to the Strengthened Senior High School Curriculum, and Preparation of SSHS Class Programs on August 26, 2026, at 9:00 a.m. via Microsoft Teams.
2. Specifically, the activity aims to:
  - a) Discuss the updated documentary requirements for Government Permit (GP) and Government Recognition (GR) applications of private schools;
  - b) Orient participants on the requirements and procedures for transitioning to the Strengthened Senior High School (SSHS) Curriculum;
  - c) Provide guidance on the application process for the Government Recognition of Private Senior High Schools;
  - d) Familiarize participants with the utilization of the Expanded Facilitative, Accessible, Streamlined, and Time-bound Application for Permit Process (E-FAST APP) System, including its application timelines and procedures;
  - e) Discuss the prescribed curriculum offerings, tracks, clusters of electives, and school calendar requirements under the SSHS Curriculum; and
  - f) Assist private schools in preparing SSHS class programs using the prescribed semestral and three-term templates.
