AMENDMENTS TO DIVISION MEMORANDUM CID-2026-135
(2026 DIVISION SCHOOLS PRESS CONFERENCE)

To: Public Schools District Supervisors Concerned
Public Elementary and Secondary School Heads Concerned

1. In reference to Division Memorandum CID-2026-135 titled **2026 Division Schools Press Conference (DSPC)**, this memorandum provides additional guidelines and amendments for the conduct of the said activity.
2. The following updates shall be observed:
 - a. Mobile Journalism (MOJO)
 - i. All MOJO qualifiers shall begin the competition at 9:00 A.M., immediately after the Mini Press Conference.
 - ii. Contestants with concurrent entries in individual and/or group events shall be accommodated and may choose to start their MOJO event either before or after their other scheduled contest, subject to the availability of proctors and competition schedules.
 - b. Contestants with Multiple Entries
 - i. Contestants qualified in two or more events, whether individual or group categories, shall be given appropriate accommodation to complete all their assigned competitions.
 - ii. Participants may prioritize and complete one event before proceeding to another.
 - iii. For group events, the remaining team members may begin the competition with or without the concerned participant. The participant may join the group upon completion of the individual event, subject to the contest rules and timeline.
3. All identified Proctors are requested to attend the face-to-face coordination meeting on September 3, 2026, at 3:00 P.M. at the Kiamba Central Elementary School SPED Center Gymnasium.
4. All identified Technical Working Group (TWG) Members shall report to Kiamba Central ESSC on September 4, 2026, to undertake final preparations and other necessary arrangements for the conduct of the 2026 DSPC.
