1. Pursuant to Executive Order No. 180, s. 1987, entitled "*Providing Guidelines for the Exercise of the Right to Organize of Government Employees, Creating a Public Sector Labor-Management Council, and for Other Purposes*," all districts are encouraged to conduct a **District Teachers Association Meeting** during the **End-of-First-Term Block**.
